 1. Contractor has completed bottom lift paving and anticipates returning at the end of July to complete projects.

- ii. US 63, Drummond to CTH E East
 - 1. Begin work week of July 5.
 - 2. Project completion the last week in October.
 - 3. Will be adding gravel to smooth low spots in Bibon Swamp.
 - 4. Single lane closures.
- iii. US 63, CTH E East to US 2
 - 1. Contractor has completed milling operations and have been paving.
 - 2. Project will mill and repave the roadway. Estimated completion in late July. Material coming from Hot Plant in Ashland.
 - 3. Bayfield and Ashland County responded to a culvert failure with crew to make emergency repairs last week.
- iv. Delta Landfill Project
 - 1. Estimate \$300,000 in county effort.
 - 2. Work continues and crew is placing erosion products.
 - 3. An extension request has been filed by Jason Bodine for a completion date in October.
 - 4. We estimate the project will be finishing up in September.
- v. Clean up Project on East View Road
 - 1. Clean up of property on East View Road for BC Land Records. Should be complete week of July 5.
- vi. Other Projects
 - 1. CTH C, STH 13 to Siskiwit Falls Rd, 0.64 Miles. CHI-D Grant \$125,000. Estimate \$262,433. Construction 2023.
 - 2. CTH A, CTH N to Correll Road, 0.9 Miles. CHI-S Grant \$176,994. Estimate \$362,490. Construction 2024.
