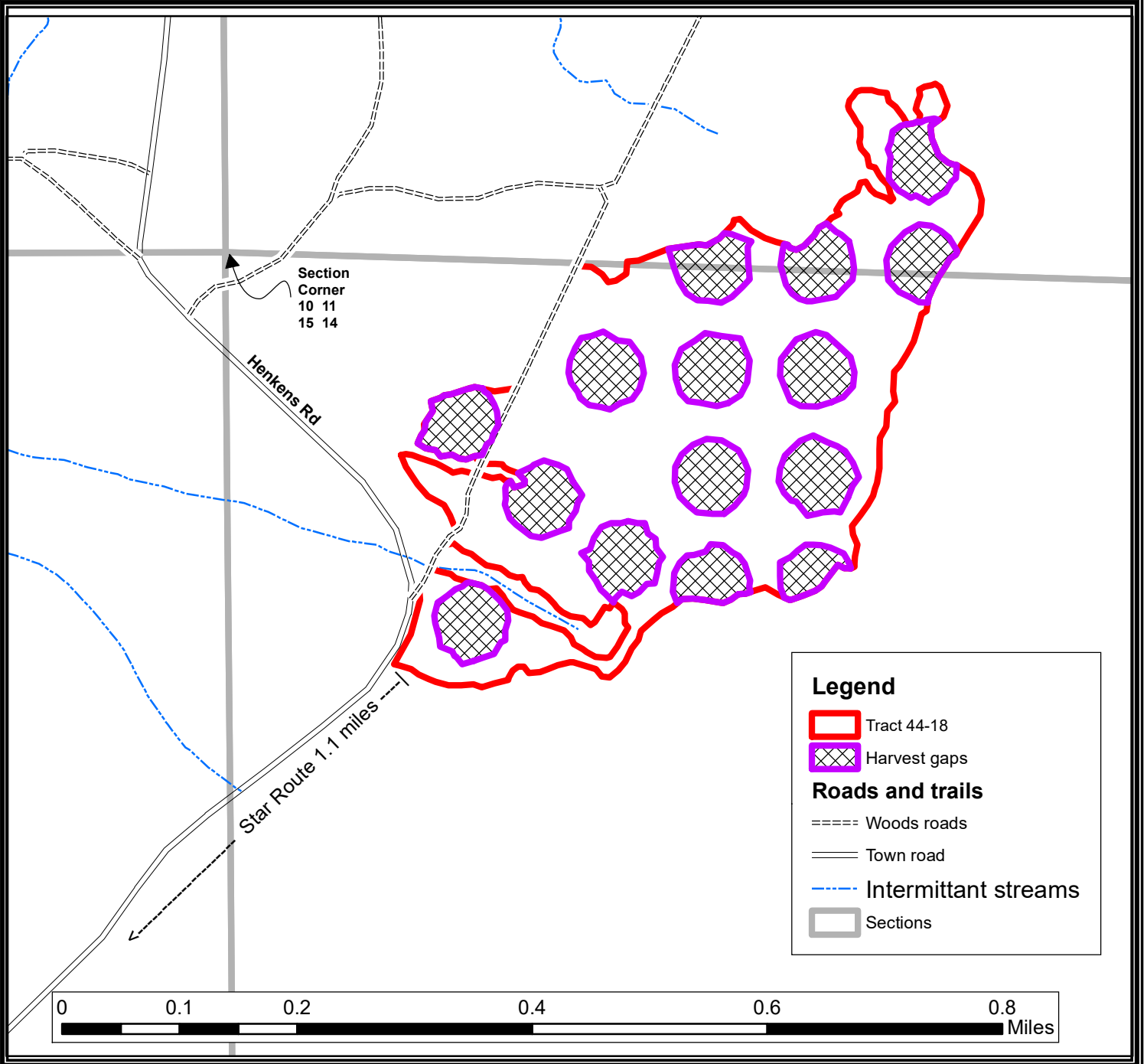

## TRACT 44-18 – SUPPLEMENTAL REQUIREMENTS

The following terms and conditions supplement those provided in the Bayfield County Timber Sale Contract.

### A. PRESCRIPTION:

**Patch Selection Harvest** - Fifteen, approximately two-acre patches (334' diameter) have been established within the sale area. Patches are spaced approximately 200 feet apart and arranged in a grid pattern. This accounts for 1/3 of the stand being harvested at this time. Each patch has its perimeter marked with purple paint - two dots facing in toward the center of the patch and a slash on the backside.

### B. HARVEST REQUIREMENTS:

1. Within each patch harvest all merchantable trees and cut all stems 1" dbh and larger except for "leave trees" which are marked with purple paint.
2. No trees are marked for removal between patches. Occasional harvest of trees less than 10" dbh will be allowed, when absolutely necessary, to travel from patch to patch using the most direct route possible. Keep the harvest of operational trees to a minimum.
3. Harvest any aspen outside of the patches that can be taken without cutting operational trees.

### C. SEASONAL RESTRICTIONS:

1. Sale operations may only occur when the ground is frozen, or during dry conditions as determined by Bayfield County.

### D. ACCESS AND ROADS:

1. This contract requires County authorization for all road/landing construction and places a number of other requirements on road construction and closure.
2. Decking of wood along town roads will not be allowed without permission from Bayfield County.

### E. OTHER:

1. To comply with Best Management Practices for Invasive Species: Prior to moving equipment onto or off the sale area, scrape or brush soil and debris from exterior surfaces to the extent practical.
2. Two riparian management zones (RMZs) 35ft wide have been designated with red paint boundary lines. Do not operate equipment in RMZ or drive across RMZ.
