

Harvest Requirements:

- This is an oak thinning being sold on a Ticket Scale Basis.
- > Sale boundaries are identifiable on the ground by existing forest roads, red painted line and blue painted line.
- > The blue line indicates private property. When harvesting adjacent to private property, no equipment or felled trees may cross the blue line.
- This map is not a survey of the actual boundaries of any properties this map depicts.
- ➤ PRESCRIPTION: HARVEST all orange-marked trees, merchantable balsam fir/spruce, aspen and ash. SEVER all ironwood stems 2" and greater. LEAVE all other conifer.
- ➤ No sale operations allowed between breakup and July 1st.
- > No cavity trees were intentionally marked for harvest. Do not cut snags except for those that pose a safety hazard.
- Sale may be whole tree harvested but not whole tree skidded due to possible damage to the residual trees. Short wood logging or pole skidding will be allowed if the purchaser can demonstrate that it can be done without causing damage to the residual stand.
- > If whole tree harvested, 1 in 10 tops less than or equal to 4" diameter must be left scattered across the site.
- A portion of the snowmobile trail will be used to access this sale. If harvested during winter conditions, the snowmobile trail must be kept unobstructed and in a packed snow condition. The purchaser must insure that harvesting and hauling operations will not create a safety hazard to snowmobiles.
- This contract requires County authorization for all road/landing construction and places a number of other requirements on road construction and closure.
- To comply with the Best Management Practices for Invasive Species: Prior to moving equipment onto or off of the sale area, scrape or brush soil and debris from exterior surfaces of the logging equipment.
- Decking of wood along town roads will not be allowed without permission from Bayfield County Forestry Department
- This contract requires County authorization for all road/landing construction and places a number of other requirements on road construction and closure. (refer to Section 17)
