

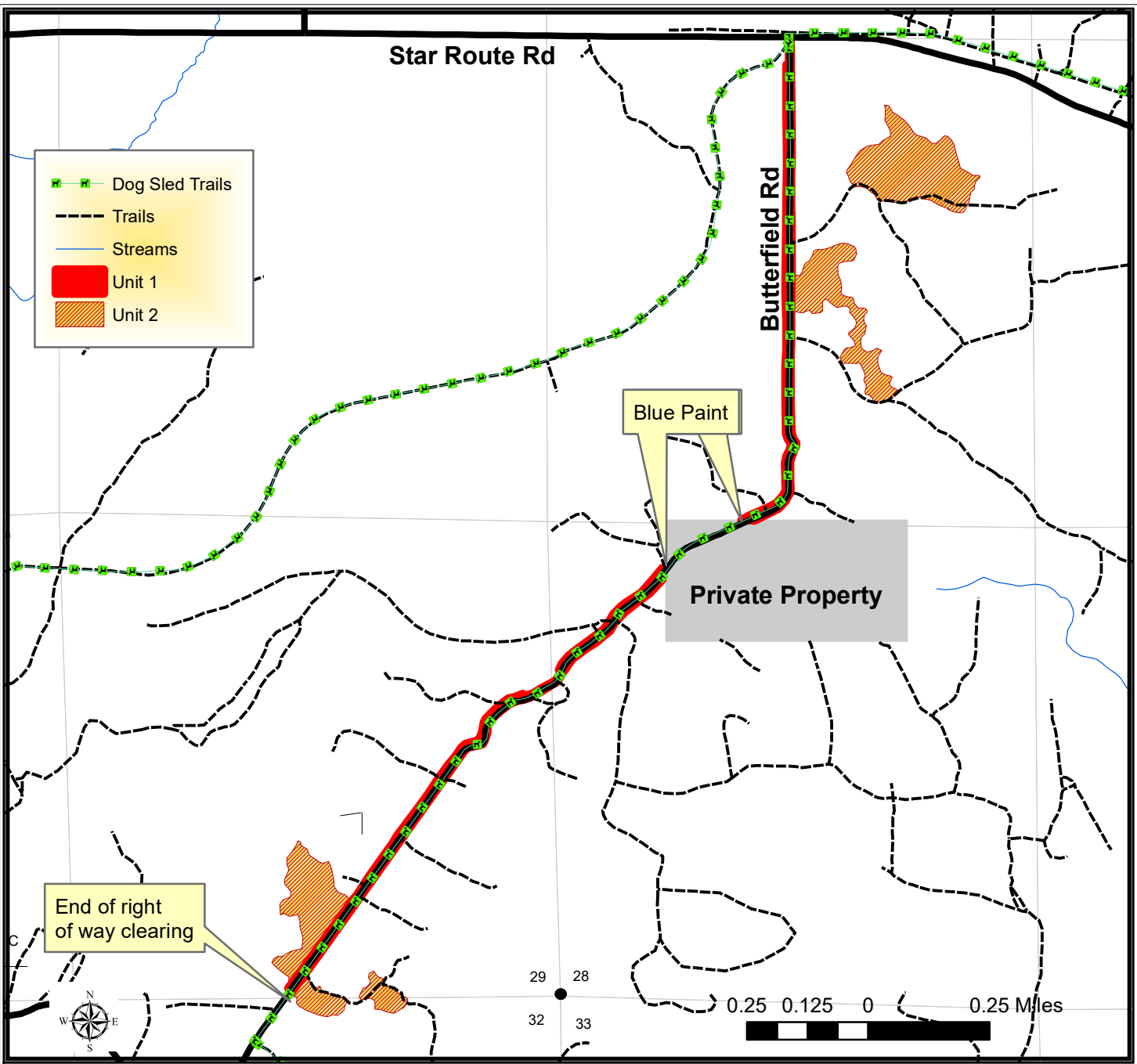

TRACT 30-21 – HARVEST REQUIREMENTS

The following terms and conditions supplement those provided in the Bayfield County Timber Sale Contract.

A. PRESCRIPTION:

1. Harvest unit 1 is a right of way clearing with an estimated average residual basal area of 0 ft²
2. Harvest unit 2 has a thinning prescription with an estimated average residual basal area of 100 ft².

B. HARVEST REQUIREMENTS:

1. In unit 1, harvest all trees greater than 4" diameter that are within 30 feet of the center of Butterfield Rd.
2. In unit 2, harvest all orange marked trees and all jack pine 6" and greater.
3. In unit 2, leave all unmarked trees except jack pine greater than 6".

C. OPERATIONAL REQUIREMENTS AND SEASONAL RESTRICTIONS:

1. When trees on the right of way are cut, tops and other slash may not be left on the right of way.
2. Sale boundaries consist of red paint line, trails, roads, or blue paint line.
3. The blue paint line indicates private property. No equipment or felled trees may cross the line.
4. Harvested pine cannot be kept on the Bayfield County Forest for more than three weeks from May 1st to August 31st.
5. If harvest will utilize the whole tree, 1 in 10 tops must be left scattered throughout the sale.

D. ACCESS AND ROADS:

1. A dog sled trail system affects this sale, as mapped.
 - i. When snow is on the ground, maintain a packed snow base on dog sled trails.
 - ii. When snow is on the ground, do not block intersections with snowbanks or berms after plowing.
 - iii. On the weekend of the Apostle Islands Sled Dog Race, no hauling will be permitted on any trails used by the race during Saturday or Sunday mornings, as determined by the sale administrator.
2. This contract requires County authorization for all road/landing construction and places a number of other requirements on road construction and closure.
3. Decking of wood along town roads will not be allowed without permission from Bayfield County.

E. OTHER:

1. The town of Bayfield will provide appropriate signage to ensure right of way harvesting can be done in a safe manor. Purchaser must coordinate with the Town to ensure signage is in place prior to right of way harvesting.
2. Utilization specification is to a 4" top. However, if the County determines that pulpwood markets continue to be very poor at the time of harvest the County will sign a contract amendment with the purchaser changing the utilization specification to a 5" top for selected species. When determining condition of the market, the County will pay particular attention to the amount of wood being purchased by the mills in Wisconsin Rapids and any other significant shifts in wood demand.
3. To comply with Best Management Practices for Invasive Species: Prior to moving equipment onto or off the sale area, scrape or brush soil and debris from exterior surfaces to the extent practical.
